

The use of the DOT symbol molded into or onto a glazed material constitutes a certification by the manufacturer and signifies that the glazed material meets applicable Federal safety requirements. While it is not required that glazed materials be tested prior to using the DOT symbol, the National Highway Traffic Safety Administration does maintain a compliance test

Area (202) 366-0123 program to enforce safety standards, and any glazed materials that are found not to meet the Federal standards, are subject to civil penalties of up to \$1000 per item but not to exceed \$800,000 for any related series of violations.

Your glazed material manufacturer's identification code mark is required on all glazed material sold in the United States for highway use. This code mark and other glazed material identification labeling are specified in the glazing material standard.

Should you no longer need a glazed material ID code mark or if:

- 1. there is a change in company or plant name or address,
- 2. the company or plant is closed,
- 3. the company or plant is sold or merges with another company, or
- 4. the types of glazed materials manufactured at each plant changes,

please notify us, in writing, immediately, including the date of the change and the month, day and year the glazed materials that were produced using the code(s) in question, so that our records can be updated.

On any future correspondence concerning a glazing material plant or the parent glazing material company, please reference the glazing material plant ID code(s) involved.
